# **Non-HRA-specific Information**

**Traffic filters presentation** - Wednesday 8<sup>th</sup> May, 7:45 p.m. - 9:15 p.m., in Headington Quarry Village Hall. In November, Oxfordshire County Council will bring in six traffic filters around the city, to speed up buses, improve their reliability, increase their frequency and introduce new routes. This meeting includes a clear, jargon-free presentation with a large map to help visualise the implications, and will answer common questions such as:

- Why are these filters being introduced?
- What do the passes mean in practice and how do I apply for mine?
- Which groups will have exemptions?

The focus will be on practicality, with plenty of time for questions and will give an understanding of how the filters will work, what they might mean for the kinds of journeys you make, and will give an indication of some choices you'll have when they are in operation.

This presentation will be given by Zuhura Plummer of Oxfordshire Liveable Streets, which is in favour of the measures, but primarily concerned with communicating these plans so people understand what is happening and why. The presentation will last for an hour, with time for Q&A, but Zuhura will be available for up to 30 mins afterwards to answer any further questions. **If you would like to attend, please register for the event <u>here</u>.** 

**Don't get caught out by the change in passport rules**. The Passport 10-year rule means that every day a hundred or so passengers heading to the EU are turned back at emigration. Explanation: A UK passport issued before September 2018 could be valid for up to 10 years and nine months because before 2018 the passport office used to add up to nine (unexpired) months from an old passport onto a new one. This means that some people have UK passports that have not officially expired, and are valid for travel in the rest of the world, but not in the EU because they were issued more than ten years ago. This did not matter while the UK was in the EU because passports were valid up to and including the expiry date. But you will now be denied travel to the EU if your passport issue date was more than 10 years ago.

### Cloning of registration plates: be prepared in case it happens to you

- The main problem for victims is that it can be extremely time-consuming to prove that their vehicle was not in the area at the time of the crime.
- What can motorists do if their vehicle registration has been cloned?

- The first recommended action for the motorist is to take a time/dated photograph of the rear of their vehicle showing individual markings or stickers. A copy of this photo can be sent to any authority in the event of a fee being demanded, and a simple comparison of this photo with the authority's photo will prove that the clone is the illegal vehicle.
- Secondly, as soon as a charge is levied, the motorist should report the offence to the police and retain the crime reference number to cover any future eventuality.
